### **2. 2010 Minutes**

The minutes from the last TGC Meeting at GAT 2010 (no Constitution changes) were accepted as written and submitted by James Sergeant.

#### 3. TGC Member School Reports

**Abilene:** Work out with High School 3-5 pm M-F.

**Baylor**: Baylor has 3 returning for last year. They charge \$75 a semester to be in the Baylor Club but this includes workouts at the Zero Gravity Club in Waco, 8-10 pm M, T, TH. They have about \$5K in their account.

**Texas:** UT works out at Crenshaw's Gymnastics Club and has about 30 members split evenly between girls and guys. They charge \$300 a year. They have about \$2K in their account. They receive about \$8500K from UT annually. They practice M-TH 8-10 pm, still at Crenshaw's.

**Texas A&M**: The Aggies workout out their gym on campus at Kyle field M-TH 6 to 9 pm. They charge \$120 a year or \$80 a semester or \$3 per day. They have about \$2300 in their account and receive \$3100 from the University. The Aggies have 9 girls and 17 guys or about 30 total. They have 2 men's teams.

**Texas State:** They have 60 to 70 members and sent 22 to Nationals last year. They work out in the same gym on campus 7-9 pm M-TH. They charge \$40 per semester.

**Texas Tech:** Tech works out at Rock Solid Athletics and charge \$101 per semester. Workouts are M-TH 7:30-9:30 pm, F 4-6 pm. They have about \$6500 in the bank and receive \$3500 in funding annually. They have about 20 members.

**UT Dallas:** They have 15 members and work out at Eagle's Wings 7-9 pm M-TH.

## 4. Unfinished Business

Some meet fees were apparently collected last year for the TGC account as the meet fees were increased by \$5 to \$10 per gymnast. The intent of the TGC meet hosts to collect the fees last year and send roster list and monies to the TGC Treasurer was sporadic. Ryan Maskell will set up a TGC account.

James Sergeant had a small Women's Judge's assigning fee that was unpaid. He offered that as a donation.

TGC Website reimbursement to James Sergeant is now at \$800 (that is not a donation). Monthly fee is
